

2007 VERMONT WILDLIFE HARVEST REPORT Wild Turkey





Most of the programs described in this report are funded through the Federal Aid in Wildlife Restoration Program. This program initiated in 1937 as the Federal Aid In Wildlife Act and created a system where by taxes are paid on firearms, ammunition and archery equipement by the public who hunts. Today this excise tax generates over a hundred million dollars each year that are dedicated to state wildlife restoration and management projects across the United States. The State of Vermont use these monies for acquiring land, and for restoring and managing wildlife. These excise tax dollars, coupled with state hunting license fees have been the predominate source of money funding the successful restoration and management of Vermont's wildlife resources.

2007 Wild Turkey Report

Spring Turkey Season

Vermont's 2007 spring season, once again set new, all-time record harvest of 5,024 bearded birds, topping the previous record harvest of 4,672 birds established in 2006. The 2007 record tally includes the 544 birds taken during the April youth turkey season, which also established a new record harvest for that two-day season.

Weather always plays a significant role in the turkey harvest. The excellent spring weather and hunting conditions experienced throughout May undoubtedly contributed to the 2007 record harvest. Hunter success rates were very high with 28.3 % of hunters harvesting at least one turkey. Among these successful hunters, 28.2 % harvested a second bearded bird to fill the two-bird spring bag limit.

Hunting pressure in 2007, measured in terms of spring turkey license sales (13,861) was slightly lower (3%) than 2006 license sales of 14,294 and 2005 sales of 13, 999 turkey tags. The number of turkey license sales during the last four to five years has remained almost unchanged. It appears that Vermont maintains a fairly stable and skilled cadre of turkey hunting enthusiasts.




Immature Birds 37% of Harvest Adult Birds 63% of Harvest

Adult birds comprised a relatively high percentage (63%) of the harvest, while immature birds comprised the remaining 37 %. The 2007 season also included 34 bearded hens in the tally. The 2007 season was the fourth consecutive year that the entire state of Vermont was open to spring hunting for all licensed turkey hunters. Birds were harvested in an unprecedented 237 of Vermont's 253 towns, by 3,919 successful hunters.




The 2007 harvest was up over last year's record in 18 of Vermont's 24 Wildlife Management Units (WMU's) lead by WMU J1 with 427 birds reported, followed by J2 (394 birds) and K2 (328 birds reported) in central Vermont. Harvests were down slightly in the northeast in WMU's D1, D2, E and H1.

Windsor County led with the highest harvest numbers reported (654 birds) followed closely by Rutland County (643) Orange County (574) and Addison (551).



The 2007 harvest is the seventh new spring turkey harvest record produced in the past ten years. In 1998, the Department's Wild Turkey Management Team initiated structural changes in the turkey hunting season to strongly emphasize high quality spring hunting over providing more fall hunting opportunities. The Team believes this management strategy helped stimulate a three-fold population increase over subsequent years, resulting in this string of record harvests. Examination of longer-term harvest trends suggests that after a fairly dramatic population increase through the period of mid- to late-1990s and into early 2000s, Vermont's turkey population may be stabilizing in the last few years near peak historic levels.

In the interest of maintaining Vermont's high quality spring turkey hunting seasons, and in light of our recent record harvests, the management team feels our current, conservative fall harvest structure is most appropriate and should be continued.



2007 LEGAL SPRING TURKEY HARVEST BY TOWN AND RESIDENCY






Fall Turkey Season


The 2007 fall season resulted in a harvest of 1,060 either-sex birds, up 283 % from the fall 2006 harvest of 374 birds and substantially higher than the previous three fall season's harvest average of 844 birds. A very poor fall hard mast crop coupled with successful spring nesting conditions in 2007 are two significant factors which likely contributed to this increased harvest. It is important to note however that fall harvests typically are poor indicators of Vermont's turkey population trend.



The 2007 fall archery-only season accounted for 78 of the harvested birds, with the balance of the birds (982) taken in the shotgun season. Fall birds were taken in 147 Vermont towns.

Fall Turkey Harvest Method of Harvest









As many of our reporting agents (and hunters) have a difficult time discerning the sex and age of fall harvested birds (particularly immature birds) we have learned to view the accuracy of our fall sex and age reported data with caution and some skepticism. Final tallies indicate immature birds comprised 37% of the harvest, while the female cohort accounted for 63% of the total harvest. Of this female component, 71% were adult birds and 29 % immature. The immature to adult female ratio was 1: 2.4.

Wildlife Management Unit J1 reported the highest number of fall birds with 178 taken, followed by WMU H2 with 129 birds and K2 reporting 107.
